Environmental Initiatives



We take our environmental impact seriously and are fully committed to reducing our carbon footprint wherever possible.

Our environmental efforts include:

- Sustainable Infrastructure: Installation of solar panels in our Douglas and Glanmire offices.
- Community Green Projects: Support for green initiatives in local schools, such as St. Columba's GNS, and collaboration with Glanmire Men's Shed to provide planters for our Glanmire office.
- Green Loans: Between January and December 2024, we issued 64 green loans totaling €1,220,000, reflecting significant growth as members become more environmentally conscious in their home renovations and vehicle purchases.
- *E-AGM*: Our 2024 Annual General Meeting was held online, increasing member participation via email invitations, reducing our print run, costs, and carbon footprint—a winwin for all.
